**Prologue:**

In response of 17 applications were received within the scheduled time i.e. date 28.07.2025. Accordingly, as per the guidelines issued by W & CD Department, Govt. of Odisha regarding selection of AWW, the documents of applicants was to be verified on 04.08.2025 in the office of the CDPO, Titilagarh.

Out of 17 applicants 15 applicants were present before the selection committee with their original documents for verification. The original documents of the applicants were verified by the selection committee. Basing on the verification of documents a tabulation sheet was prepared & recorded in a register with instruction to publish the same as per guidelines of Government. The CDPO, Titilagarh published the findings of the committee in respect of Nativity, Educational Qualification & Caste etc. in Notice no. 1166 dated 05.08.2025 in the concerned village, Notice Board of concerned GP, Panchayat Samiti Office, Titilagarh & CDPO Office, Titilagarh inviting objection in this regard. Accordingly, One no of objection was received through online by CDPO within the scheduled time.

**Proceeding:**

The committee members examined all the documents submitted by the applicants. One objection was received both in online and offline mode. A statement showing objection was noted below.

The objection received from the candidate namely Jayashree Chhura the matter was verified as per the report of Lady Supervisor it was found that Renuka majhi is not a resident of Balpadar. As such the committee unanimously decided to reject her candidature and prepared the merit list as per the rest of candidates given in Annexure-1.

Basing on the documents furnished, view of selection committee against the objections received & service area verification report of I/C AWW, Balpadar by name Puspanjali Majhi concerned Sector Supervisor & CDDO, a tabulation was prepared which is given at Annexure-1.
